- 2. All Purchase Excel Register.
- 3. Sales Excel Register.
- 4. Expenses Bills / Voucher information in Excel sheet.
- 5. Self Invoice Bills under Reverse Charge. (If Any)
- 6. Tax Cheque & Fees Cheque.

#### PLEASE NOTE:

#### GST RETURNS:

- GSTR1: Due Date: Before 5th of every month (Sales Bills are required to be filed on Time in R1 for ITC credit)
- GST3B: Due Date: Before 5th of every month (In this Return GST Tax is required to be paid on Time.)
- Late Filing of GST Returns Attract Late fees (System Calculated)
- Timely Filing of All GST Returns is *Compulsory*.
- Late Filing of GST Returns : Purchaser will not Get ITC if Not Filed on Time.
- GST Registration May Get <u>Cancelled or Suspended if Returns Are Not Filed within</u> <u>Due Dates</u>

### • PURCHASE ITC:

- Input Tax Credit: will be Considered As Per Portal / 2B Data (Portal Reflection ONLY)
- For Purchases: Payments need to Be Made within 180 days
- ITC: Now 2B Data is Important.
- Business Related Purchases are eligible for ITC : <u>Personal Purchases are Not Eligible</u>
- ITC : Excess ITC Other Than Books will Be Required to be Reversed (Interest will be Required)

### GST PAYMENT:

- Timely Payment of GST is Important : Avoid Late GST Payment
- Late Payment of GST: Attracts Interest for Delayed Payments @ 18%
- Pay GST Tax on or Before the Due Date as mentioned above
- Please Submit GST Data Before 5th of Every Month
- GST is Applicable on Commercial Rent (Not Applicable on Residential)
