Revised timetable for the introduction of controls

A new timetable for introducing import border control processes was set out by the government on Thursday 11 March to enable UK businesses to focus on their recovery from the COVID pandemic.

The government has listened to businesses who have faced an unprecedented challenge during the pandemic and will now introduce full border control processes six months later than originally planned.

The revised timetable for the introduction of controls, as follows:

From 1 October 2021:

- Pre-notification requirements will be required for products of animal origin, high risk food not of animal origin (HRFNAO) and certain animal by products.
- Export health certificates will be required for products of animal origin and certain animal by-products.

From 1 January 2022:

- Safety and Security declarations for imported goods will be required.
- Physical SPS checks for products of animal origin, certain animal by-products, HRFNAO and high risk plants will take place at Border Control Posts.
- Prenotification requirements and documentary checks, including phytosanitary certificates will be introduced for low risk plants and plant products.
- Customs declarations on all goods will be required at the point of import and businesses will no longer be able to use the deferred declaration scheme.

From 1 March 2022:

• Checks at Border Control Posts will take place on live animals, low risk plants and plant products.

This will provide businesses with further time to prepare for changes at the border and minimise disruption as the economy gradually reopens, as the government recognises the scale and significance of the challenges businesses have been facing in adjusting to the new requirements.

Although we recognise that many in the border industry and many businesses have been investing time and energy to be ready on time, we have listened to businesses who have made a strong case that they need more time to prepare. In reviewing the timeframes, we have given strong weight to the disruption which has been caused, and is still being caused, by COVID, and the need to ensure that the economy can recover fully.

Traders moving controlled goods into Great Britain will continue to be ineligible for the deferred customs declaration approach. They will therefore be required to complete a full customs declaration when the goods enter Great Britain.

Controls and checks on Sanitary and Phytosanitary goods are of course a devolved matter and we continue to work closely with the Devolved Administrations on their implementation, in particular with the Welsh Government on their timetable for completing supporting Border Control Post infrastructure in Wales.

We will continue to engage extensively with businesses like yourself to support you in adjusting to the new requirements already in place and to prepare for the new requirements set out above so that you can continue to trade successfully under the new arrangements. An updated Border Operating Model will be published in due course.

Suspension of Operations at Manston

From the 21 March, all haulier processing operations, including COVID testing for hauliers, will be suspended at Manston Airport. If heading to the Port of Dover or Eurotunnel, you will be directed straight onto to the M20. Free COVID testing for hauliers is still available at one of the many <u>Information and Advice sites</u>, and Inland Border Facility checks will continue to be processed by Ashford Sevington, or one of the other sites <u>across the country</u>. Hauliers are strongly encouraged to get a negative COVID-19 test, to use the Check an HGV is Ready to Cross the Border service and get a valid Kent Access Permit before arriving in Kent to minimise delays. Please also follow any traffic management signs.

Planned GVMS downtime on Sunday 21 March 2021 between 00:00 – 02:00 GMT

As part of our ongoing IT improvement there will be a short period of Goods Vehicle Movement Service (GVMS) downtime on Sunday 21 March 2021 between 00:00 – 02:00 GMT.

Carriers

Hauliers

Hauliers should ensure they complete all GVMS related actions prior to arriving at the port for their journey before 00:00 GMT on 21 March 2021. It will not be possible to make amendments or updates to Goods Movement References (GMR) during this downtime. We have contacted Carriers who may be impacted to inform them of the period of downtime.

Restrictions on entering the Netherlands

From Tuesday 16 March, hauliers returning to the Netherlands from the UK having spent less than 48hrs in the UK no longer require a Covid-19 test. This measure mirrors the one we agreed with France on 21 Feb. The modification has been agreed by the Dutch Parliament.
